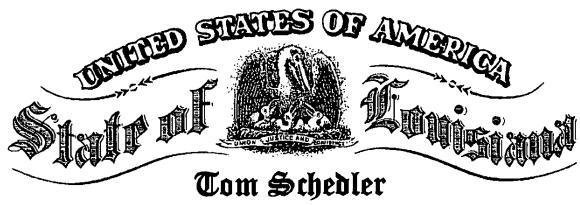

# ARTICLES OF ORGANIZATION OF WASHER, HILL AND LIPSCOMB,(LA) L.L.C.

The undersigned, for the purposes of forming a Limited Liability Company in accordance with the Louisiana Limited Liability company Law, hereby adopts the following Articles of Organization:

## ARTICLE 1. Name

The name of the Limited Liability Company is WASHER, HILL AND LIPSCOMB, (LA) L.L.C.

# ARTICLE 2. Purpose

The purpose of the Company is to engage in any lawful activity for which Limited Liability Companies may be formed under the Louisiana Limited Liability Company Law.

# ARTICLE 3. Management

The above enumerated powers and authority shall be limited to LARCHE RUSSELL WASHER, MICHAEL W. HILL and RICHARD P. LIPSCOMB. Subsequent managers will be limited by the operating agreement.

#### ARTICLE 4.

Term

The term of the company shall be perpetual.

# ARTICLE 5. Duties and Operating Procedures

A statement of the duties and operating procedures for the members and managers will be included in a written operating agreement. Any action or actions taken by said member or manager which is/are contrary to said duties and/or operating procedures will be considered a breach of said member's or manager's fiduciary duties to the Limited Liability Company.
