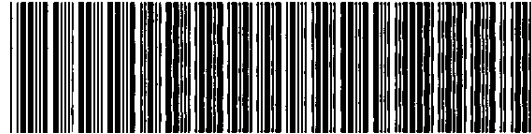

- Prophase:** The chromosomes are condensing and becoming visible. The nuclear envelope is breaking down.
- Metaphase:** The chromosomes are aligned in the center of the cell (the metaphase plate).
- Anaphase:** The sister chromatids are separating and moving toward opposite poles of the cell.
- Telophase:** The chromosomes have reached the poles, and new nuclear envelopes are forming around them.
