

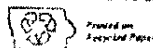

Pursuant to Section 1101 of the Iowa Limited Liability Company Act, the undersigned adopts the following articles of amendment to the articles of organization for the company:
