We received your request for a letter with more detail regarding the activities of Florida Income Group, LLC (the "Company") in the State of Florida and the confusion regarding the requirement to register with the Division of Corporations in 2004. Florida Income Group, LLC acquired title to Florida real property in 2004. Pursuant to Section 607.1501(2)(m), Florida Statutes, activities that do not constitute transacting business within the State of Florida, include, "owning, without more, real or personal property." On advice of counsel, Florida Income Group, LLC was told that it was exempt from registration because it did not do "more" than hold title to real property in the State of Florida. In an internal audit of the Company's activities, the Company sought a second opinion from separate legal counsel regarding whether the Company was required to be qualified in the State of Florida. The Company was informed that, because the Company had collected rental income on the property it had acquired, such activities constituted "more" than just owning real property, and therefore the Company was advised that it needed to obtain a Certificate of Authority from the Department of State to transact business in the State of Florida.
