Regency Imaging Center, Inc., a Florida corporation (which is hereinafter called the "Corporation"), hereby certifies to the Florida Department of State that:

FIRST: The name of the Corporation is "Regency Imaging Center, Inc."

SECOND: The dissolution of the Corporation was authorized on September 25, 1996.


THIRD: Dissolution of the Corporation was approved in the manner and by the vote required by law and by the Articles of Incorporation of the Corporation. Pursuant to the provisions of Section 607.1402 of the Florida Business Corporation Act, by written consent dated as of September 25, 1996, signed by all of the shareholders of the Corporation, the shareholders of the Corporation authorized the dissolution.


FOURTH: The Corporation is hereby dissolved.
