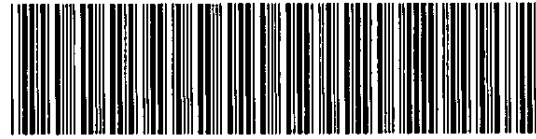

We have received your document for PELICAN MACHINERY AND EQUIPMENT, LLC and your check(s) totaling \$35.00. However, the enclosed document has not been filed and is being returned for the following correction(s):

Please note that we have RETAINED your \$35.00 payment.

Because PELICAN MACHINERY AND EQUIPMENT, LLC is a Delaware LLC, it cannot file a Florida LLC Amendment.

It could file a FOREIGN LLC Amendment. However the Foreign LLC Amendment requires certification from the homestate -- either a certified copy of an amendment filed in the homestate, or a good standing certificate from the homestate.

A Foreign LLC amendment cannot be filed without a certificate of some kind.

But in cases in which ONLY mangers or managing members are being changed, a foreign LLC could file an AFFIDAVIT TO CHANGE MANAGERS OR MANAGING MEMBERS. The fee to file the AFFIDAVIT is the same as the Amendment fee -- \$25.00.

But the AFFIDAVIT doesn't require any certification from the homestate.

To save the cost of paying for certificates from Delaware, we would recommend that you use the AFFIDAVIT form for your filing.

Please return your document, along with a copy of this letter, within 60 days or your filing will be considered abandoned.
