To whom it may concern,

I have enclosed two different filings for CTM Capital Management, LLC. The first is a dissolution of the LLC as a Florida LLC and the second is the registration of the LLC as a foreign LLC which it should be since it was formed in the state of Delaware. When I was opening a bank account late last year I was told I needed a Florida registration to open the bank account and I mistakenly filed as a Florida LLC instead of a foreign LLC. I discussed the matter with a department of state representative and she said the procedure to correct the matter would be to file the dissolution and then file again as a foreign LLC. Thus please dissolve the Florida LLC prior to making the foreign filing as they obviously have the same tax ID number.

I have also attached a check for \$1,000.00 to cover any penalties arising from the incorrect filing. In reviewing FL statutes 608.501 & 502 I was not operating in Florida in 2008 but would, I believe, be considered to be operating as of March 1, 2009 thus the enclosed check to cover penalties.
