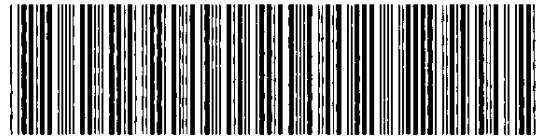

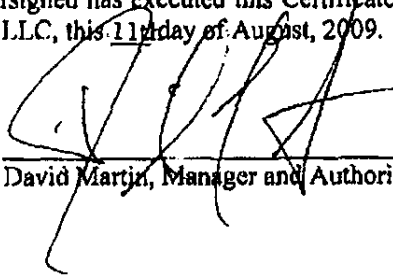
1. The name of the limited liability company (hereinafter called the "Limited Liability Company") is GreenBid, LLC.
