

## THIRD AMENDMENT TO OPERATING AGREEMENT OF FIDELITY GROUP INSURANCE PROFESSIONALS, LLC

THIS THIRD AMENDMENT TO THE OPERATING AGREEMENT OF FIDELITY GROUP INSURANCE PROFESSIONALS, LLC (hereinafter "FGIP"), is made and hereby adopted as of this day of \_\_\_\_\_\_\_\_\_, 2015, by and among Craig Seiler. Rob Hissong and Peter A. Mallouk, trustee (hereinafter sometimes referred to individually as "Members")

### RECITALS

- (A) The above named Members desire to amend the Operating Agreement of FGIP, executed on or about February 28, 2003, with Amendments to Operating Agreement executed on or about January 11, 2008 and January 1, 2011 in accordance with the laws of the State of Kansas.
- (B) It is still the desire of all the Members to be bound by all terms and provisions with respect to the original Operating Agreement and all Amendments unless such terms and provisions are specifically restated herein;

NOW, THEREFORE, in consideration of mutual covenants and for the other good and valuable consideration, the parties agree to the following Amendments to the Operating Agreement executed on or about February 28, 2003 and the various Amendments, as well as any additional Terms and Provisions added herein:

### **AMENDMENT**

(TO OPERATING AGREEMENT EXESUTED ON OR ABOUT 2/28/03 and the First and Second Amendments to Operating Agreement)

## ARTICLE I THE LIMITED LIABILITY COMPANY

#### Section 1.01. Formation of Limited Liability Company

(a) The name of the Company shall be changed and the business and affairs of the Limited Liability Company shall be conducted under the name "CREATIVE PLANNING PROPERTY & CASUALTY, LLC" and such name shall be used when conducting business in an official capacity in connection with the Limited Liability Company=s business and affairs. The Company may choose to simply use the name "Creative Planning" in its marketing materials with the general public.

### RESOLUTIONS OF THE MANAGING MEMBERS AND OF THE OTHER MEMBERS OF

### FIDELITY GROUP INSURANCE PROFESSIONALS, LLC (A Kansas Limited Liability Company)

The undersigned, being all of the Members (the "Members") of FIDELITY GROUP INSURANCE PROFESSIONALS, LLC, a Kansas limited liability company (the "Company"), hereby adopt the following resolutions in the name of and on behalf of the Company:

1. Approval of Name Change. The Members have unanimously approved changing the name of the Company from Fidelity Group Insurance Professionals, LLC (currently operating under the trade name of "Creative Planning Risk Services") to Creative Planning Property & Casualty, LLC. The Company will operate under its new name or simply "Creative Planning". In addition to changing the name with the Kansas Secretary of State, all necessary changes with Kansas Dept. of Insurance and updating any contracts with specific insurance carriers will commence as soon as possible.

2. Signatures. This Resolution may be signed in two (2) or more counterparts, each of which shall be deemed to be an original, but all of which shall constitute one and the same instrument.
