

The name of the corporation is KNU, LLC.



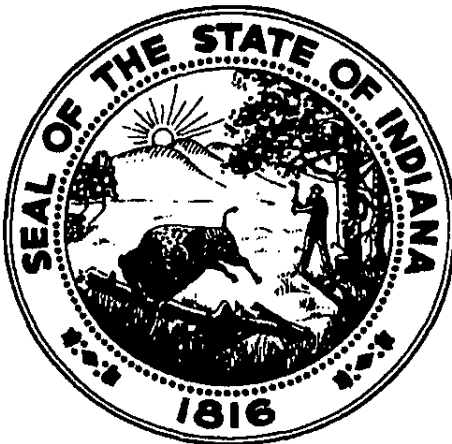
