To Whom it May Concern,

On April 15 I sent the paper work with a check to the Division of Corporations. This paper was prepared by my accountant and forwarded with an envelope to me. The check was made out wrong and somehow it ended up with the Department of Revenue. I have requested a refund from them for the 150%. This was not for Intangible Taxes as that check was for over \$3400 - all my paper work shows that I had sent the papers to the Division of Corporations.

When I found out you had not received the check and paper work as you had said, I sent a new check + paper work. you sent me a letter and requested a penalty of \$400. plus the 150%, which you still have, plus \$8.75. which totaled \$558.75. I don't know how this check ended up with the Dept. of Revenue, and that you don't have the original paper work. There seemed to be some kind of mix up. I would appreciate it if the penalties could be waived. I have always sent my paper work in on time.
