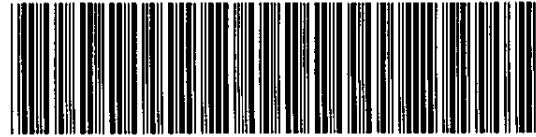

I represent both the above limited liability companies. JSF Manufacturing, LLC is a Delaware LLC which has been authorized to do business in Florida for several years but ceased doing business in Florida on January 1 of last year. JSF Technologies, LLC is a North Carolina LLC which now applies for authority to do business in Florida. It began doing business in Florida on January 1 of last year.

JSF Manufacturing merged into JSF Technologies around January 1 of last year. JSF Manufacturing then ceased to exist. Nonetheless, JSF Manufacturing filed an annual report for 2012 and paid the annual fee.

Enclosed is JSF Manufacturing's application for withdrawal and a check in the amount of \$25 in payment of the filing fee. Also enclosed is JSF Technologies application for authorization to transact business with the registered agent's certificate and a certificate of existence from the North Carolina Secretary of State. A check in the amount of \$70 is enclosed in payment of the \$125 filing fee less the \$55 credit for previous payment on invalid name change filed in November by JSF Manufacturing.


