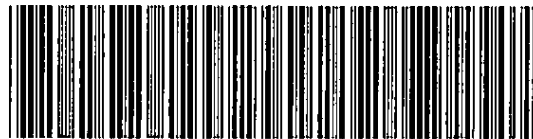

FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

THIS CAUSE having come to be considered upon the Verified Petition for Dissolution of Marriage and Other Relief filed by the Petitioner/Wife, **SHERRI A. WILLIAMS** and the Acceptance of Service of Process, Answer, Waiver of Appearance and Request for Copy of Final Judgment of Dissolution of Marriage filed by Respondent/Husband, **GLEN R. WILLIAMS**. The Court, having reviewed the Court file, and being otherwise sufficiently advised in the premises, **FINDS, ORDERS, AND ADJUDGES** as follows:

1. The Husband and Wife married on April 7, 2001 in Chandler, Arizona.
2. There was one child born of the marriage, but she has reached the age of majority. No other children were adopted during the marriage. The Wife is not currently pregnant, and no other children are anticipated.
3. The Wife has been a resident of the State of Florida for more than six (6) months immediately preceding the commencement of this action.
4. DISSOLUTION OF MARRIAGE.

The marriage between the parties is irretrievably broken. The bonds of marriage shall be hereby dissolved and the parties shall be restored to the status of single.


5. MARITAL SETTLEMENT AGREEMENT.

The parties freely and voluntarily entered into a Marital Settlement Agreement, which was filed in the Court file on November 15, 2019 and a copy of which is attached hereto as Exhibit A. The Marital Settlement Agreement is a full and complete settlement of all matters relating to the parties' marriage, including the division of the parties' marital assets and liabilities and attorney's fees. The Marital Settlement Agreement is hereby approved, ratified, and incorporated into this Final Judgment by reference as if the terms were recited verbatim herein. The Marital Settlement Agreement shall survive entry of this Final Judgment and the parties are ordered to comply with the terms of same.

6. RESTORATION OF MAIDEN NAME. The Wife's legal name shall hereby be restored to her maiden name, **SHERRI ANN SNOW.**

7. The Court has jurisdiction over the parties and subject matter herein. The Court retains jurisdiction over this matter to enforce the terms of the Marital Settlement Agreement and this Final Judgment and for any other purpose necessary to effectuate the terms therein.
