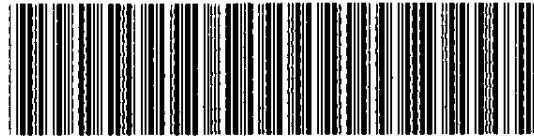

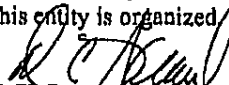

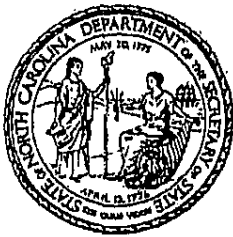

2. The text of each amendment adopted is as follows:

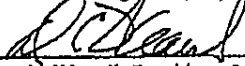
The text of Article I of the Articles of Organization is deleted in its entirety and the following text is inserted in lieu thereof:
