

BEFORE ME, the undersigned, a Notary Public, duly commissioned and qualified and in the presence of the undersigned witnesses, personally came and appeared the undersigned Organizer, of the full age of majority, who declared that, availing Organizer of the provisions of the Louisiana Limited Liability Company Law, Organizer does organize Organizer, Organizer's successors and assigns, into a Limited Liability Company pursuant to law, under and in accordance with the following Articles of Organization, to-wit:

ARTICLE I.

The name of the Limited Liability Company is: Dick's Wings LA, LLC.

ARTICLE II. OBJECTS AND PURPOSES

The objects and purposes for which the Limited Liability Company is organized and the nature of the business to be carried on by the Limited Liability Company are stated and declared to be as follows, to-wit:

whatsoever in any other states of the United States of America, any territory of the United States of America and any foreign nations to the extent permitted by the law of such other states, territories or nations."

ARTICLE III. PRINCIPAL PLACE OF BUSINESS

ARTICLE IV. TRANSFER OF MEMBERSHIP INTEREST AND ADMISSION OF ADDITIONAL PARTNERS

 - a) The reduction of the number of members to one (1), however, the Limited Liability Company shall not terminate if, within ninety (90) days of the reduction of the number of members to one (1), an additional member is admitted to the Limited Liability Company in accordance with the Operating Agreement or the sole remaining member elects to continue as a single member Limited Liability Company;
 - The unanimous consent of the membership units to dissolve and liquidate the Limited Liability Company; and,
 - c) The entry of a decree of judicial dissolution of the Limited Liability Company pursuant to La.R.S. 12:1335; or,
 - d) Such other event as may be set forth in the Operating Agreement.

ARTICLE VI. MANAGEMENT

The business of the Limited Liability Company shall be conducted by one or more Manager, whose identity is on file with the Louisiana Secretary of State. The Manager need not be a member of the Limited Liability Company.

ARTICLE VII. MANAGER'S CERTIFICATE
