The following Articles of Merger are submitted in accordance with Florida Statutes Sections 605.1021 through 605.1026, inclusive, to effect the merger of Solid Resources, LLC, a Florida limited liability company (the "*Target*"), with and into its sole member, O'Brien's Response Management, L.L.C., a Delaware limited liability company (the "*Survivor*") (the "*Merger*"). The plan of merger ("*Plan of Merger*") is as follows:

PLAN OF MERGER

1. The name and jurisdiction of the surviving entity:

O'Brien's Response Management, L.L.C., a Delaware limited liability company (Florida Document Number M13000002248).

2. The name and jurisdiction of the merging entity:

Solid Resources, LLC, a Florida limited liability company (Florida Document No. L04000071345).

3. Effective Date. The Merger shall be effective as of May 31, 2016.

4. Converting Membership Interests and Liabilities; Governing Law. On the Effective Date of the Merger, the outstanding membership interests of Target shall, by virtue of the Merger and without any action on the part of any holder thereof, be cancelled and no longer represent an interest in Target, and Survivor shall pay to the sole member of Target Ten and 00/100 Dollars (\$10.00). In exchange for the membership interests of Target being cancelled, Survivor shall accept the liabilities of Target. The issued and outstanding membership interests of Survivor shall not be affected by the Merger. The Survivor shall continue to be governed by the laws of the State of Delaware.

5. Adoption of Merger by Survivor. The Merger and the Plan of Merger set forth herein were approved and adopted on May 18, 2016, by unanimous written consent of the Board of Managers and the sole member of Survivor, in accordance with the Delaware Limited Liability Company Act.

6. Adoption of Merger by Target. The Merger and the Plan of Merger set forth herein were approved and adopted on May 18, 2016, by unanimous written consent of the sole
