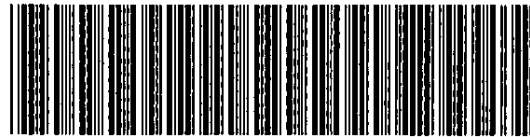

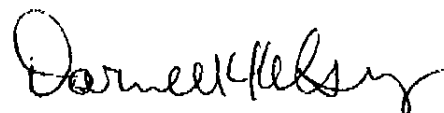
Hello Tammy Hampton,

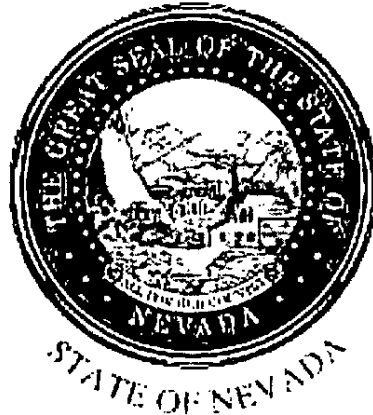
