Dear FL Department of State:

Company Voice, LLC (Company Voice) previously registered as a Foreign Limited Liability Company with the Florida Department of State. Upon further review, however, we believe Company Voice is exempt from registering as such.

Florida law provides that "a foreign limited liability company may not transact business in this state until it obtains a certificate of authority from the Department of State." Florida law also provides that the following activities, among others, do not constitute transacting business in Florida: (1) "soliciting or obtaining orders, whether by mail or through employees, agents or otherwise, if the orders require acceptance outside this state before they become contracts;" and (2) "transacting business in interstate commerce."

Company Voice does not engage in intrastate business in Florida, as it has no physical presence in the state. Indeed, the only business activity it conducts in Florida occurs via telephone through its employees and/or agents, which are located outside of Florida. These telephone calls, by their very nature, constitute interstate commerce. Similarly, to the extent that sales are made with Florida residents, those sales must be accepted outside of Florida before becoming binding contracts.
