THIS AGREEMENT AND PLAN OF MERGER is adopted by ENTEGRA ROOF TILE DELIVERY, LLC, ENTEGRA ROOF TILE SALES, LLC, and ENTEGRA ROOF TILE, LLC (collectively, the "Merging Entities"), all of which are limited liability companies organized under the laws of the State of Florida, by action of all of its members, and is also adopted by Roof Tile Acquisition, LLC ("Roof Tile"), a limited liability company organized under the laws of the State of Delaware, by action of all of its members.

- I. - 3. The present Operating Agreement of the surviving entity will be the Operating Agreement of said surviving entity and will continue in full force and effect until changed, altered, or amended as therein provided and in the manner prescribed by the provisions of the Delaware Limited Liability Company Act.
- 4. Upon consummation of the merger, all of the membership interests of the Merging Entities which are outstanding immediately prior to the merger shall be cancelled.
- 5.
