ARTICLES OF MERGER

of

MEDMAR DEVELOPMENTS, LLC a Florida limited liability company (merging limited liability company)

with and into

MATTAMY TAMPA/SARASOTA LLC a Delaware limited liability company (surviving limited liability company)

These Articles of Merger are dated December 9, 2020 and are entered into pursuant to Section 605.1025 of the Florida Revised Limited Liability Company Act (the "Act").

1. The name of the merging entity is Medmar Developments, LLC, a Florida limited liability company.

2. The name of the surviving entity is Mattamy Tampa/Sarasota LLC; a Delaware limited liability company.

3. The merger was approved by each domestic limited liability company, in accordance with Sections 605.1021 - 605.1026 of the Act; by each other merging entity in accordance with the laws of its jurisdiction; and by each member of such limited liability company who as a result of the merger will have interest holder liability under Section 605.1023(1)(b) of the Act and whose approval is required.

4. The surviving entity has agreed to pay any members of any limited liability company with appraisal rights the amount to which such members are entitled under the provisions of Sections 605.1006 and 605.1061 – 605.1072 of the Act.

5. The effective date of the merger is the date of filing these Articles of Merger with the Florida Department of State, Division of Corporations.
