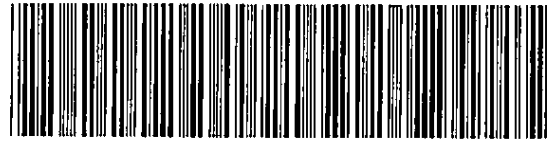

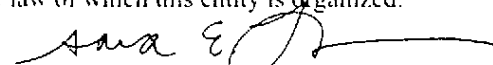

ARTICLES OF MERGER AND STATEMENT OF MERGER

Pursuant to the Iowa Revised Uniform Limited Liability Company Act and the Iowa Business Corporation Act, the undersigned execute the following Articles of Merger and Statement of Merger:

FIRST: Wellabe Holdings, Inc., an Iowa corporation, The Entrecor Group, LLC, an Iowa limited liability company, and American Republic Insurance Services, LLC, an Iowa limited liability company, are the parties to the merger.

SECOND: The merging entities that are not the surviving entity are Wellabe Holdings, Inc., an Iowa corporation, and American Republic Insurance Services, LLC, an Iowa limited liability company (each such entity is a "Non-Surviving Company").

THIRD: Subject to paragraph 8 below, the merging entity that is the surviving entity is The Entrecor Group, LLC, an Iowa limited liability company (the "Surviving Company").

FOURTH: The merger has been approved by the Surviving Company and each Non-Surviving Company as required by the Iowa Business Corporation Act and the Iowa Revised Uniform Limited Liability Company Act.

FIFTH: The merger and amendment described below shall become effective as of 12:01 A.M. Central Standard Time on June 30, 2024.

SIXTH: The Plan of Merger was duly approved by the shareholders of Wellabe Holdings, Inc., an Iowa corporation.


SEVENTH: The Surviving Company filed its Certificate of Organization on December 24, 2013.

EIGHTH: Section 1 of the Surviving Company's Certificate of Organization is deleted in its entirety and replaced with the following: The name of the limited liability company is American Republic Insurance Services, LLC (the "Company").

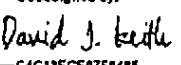

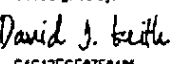
