#### To Whom It May Concern:

Please find enclosed a corrected application for Sparker Enterprises, LLC, a foreign LLC, to transact business in the state of Florida. The original filing was submitted by Dr. Mark Hashim, a client of ABA, in early March. The original filing contained two mistakes, both of which are listed below and have been corrected:

- 1. The original filing did not contain a Certificate of Compliance (known as a "Certificate of Good Standing" in Florida) from the entity's home state. Enclosed in this updated filing is an active certificate which shows the status of Sparker Enterprises, LLC in Alaska.
- 2. Due to a misunderstanding by the client when filling out the original filing, there was an error made with regard to the date on which the LLC transacted business in Florida. The original filing listed a date of May 1, 2011, which is not correct. This entity is currently applying for foreign LLC status so that it may conduct business in Florida. The date listed by the client corresponds to the first date the LLC produced and recorded income. This date is not specific to Florida accordingly, there was no affiliation between Sparker Enterprises, LLC and Florida at this point. Despite listing a Florida address associated with Dr. Hashim, who was acting as Manager, the entity has been operating in both Alaska and Illinois, and has yet to transact business in Florida.

Because the entity did not transact in Florida prior to qualification, the penalty fees listed in the rejection letter (Letter Number: 114A00005417) should not apply. The \$916.25 fee was based on an incorrect response to a question on the original filing answered by the Manager, and was submitted without final approval of an attorney.
