Dear Ms. Milligan:

I am writing on behalf of fourteen (14) South Carolina limited liability companies which submitted the above-referenced Applications By Foreign Limited Liability Company for Authorization to Transact Business in Florida.

By letter dated April 18, 2014 (copy enclosed), all of the above-referenced applications were rejected for two reasons. One reason was that the registered agent must sign the application. Please find enclosed copies of all the applications, signed by the registered agent for each, Corporation Service Company, which resolves that issue. The second reason the applications were rejected was that according to the applications, each of the entities began transacting business prior to registration with the state. As a result, the Division of Corporations believed that civil penalties and annual report filing fees were due from each of the entities.

In our recent conversation on May 14th, I explained that we don't believe that the activities of these applicants constitute doing intrastate business in Florida such that registration in Florida would be necessary; but that each entity nonetheless submitted an application because of a request made by the Osceola County Tax Collector in connection with the payment of Tourist Development Tax in that county. Essentially, we decided to accommodate the request of the Tax Collector rather than argue the point with him.

Each of the foreign limited liability companies in question exists for the sole purpose of owning one condominium unit and making that unit available to an affiliate as part of an interstate commercial activity, which exempts the applicants from the registration requirements under Florida Statutes Section 607.1501(i). Long-term leases have been entered into between the affiliates to formalize the arrangement.

As we discussed, on the enclosed applications, I have stricken out the date previously stated as the date that each of the entities began transacting business in Florida. Those dates were the dates that each of the individual long-term leases commenced. However, as explained above, we should not have presented the information this way. I have also corrected the title of the signatory.

Accordingly, I would appreciate it if you would process the enclosed revised applications. The Division of Corporations already has our check for the application fees. For your convenience, a copy of this letter is attached to each revised application.
