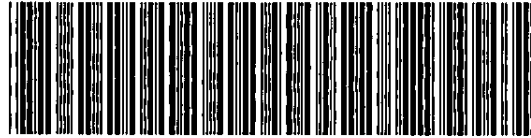

The fees to register are as follows: \$100.00 filing fee for application, \$25.00 designation of registered agent, \$30.00 certified copy (optional) and \$5.00 certificate of status (optional).

A transmittal letter should be submitted along with the application, certificate and check.

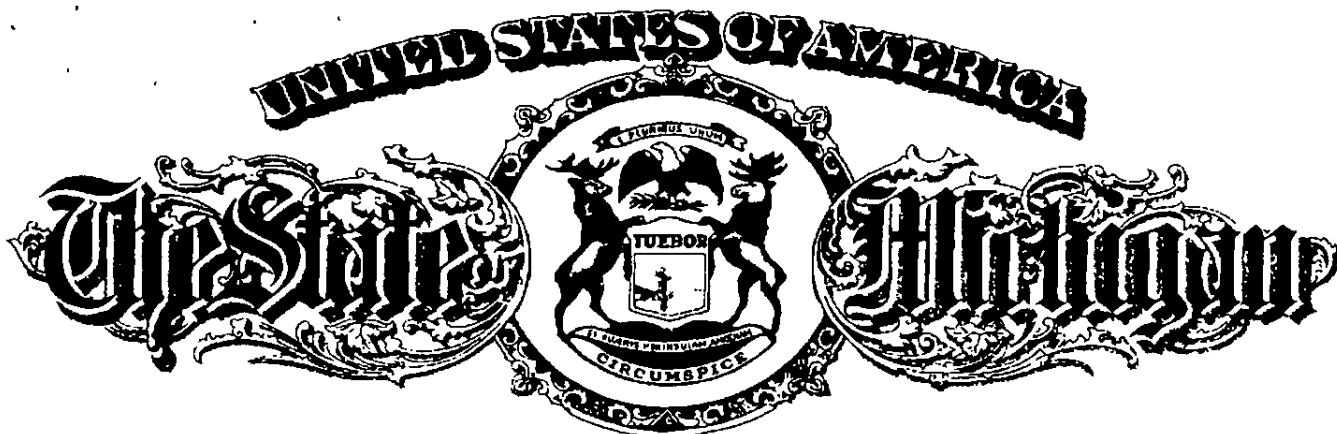
