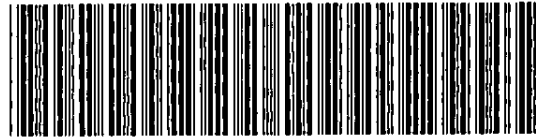



We intended to register On Porpoise, LLC as a foreign limited liability company to transact business in Florida; however, we inadvertently filed Articles of Organization for On Porpoise, LLC on March 3, 2015 (File Number L15000039411) instead of an Application by Foreign Limited Liability Company for Authorization to Transact Business in Florida.





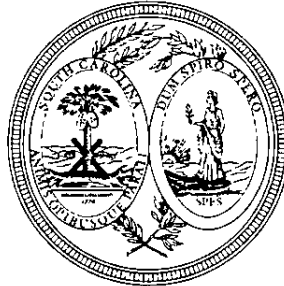
