



We intended to register Mayports Assisi, LLC as a foreign limited liability company to transact business in Florida; however, we inadvertently filed Articles of Organization for Mayports Assisi, LLC on March 26, 2015 (File Number L15000054081) instead of an Application by Foreign Limited Liability Company for Authorization to Transact Business in Florida.
