
Our apologies that it took more than the 60 days for us to receive the requested Certificate of Good Standing from the State of Delaware.



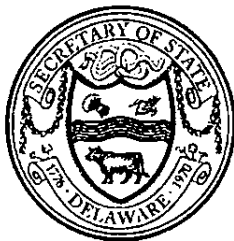


