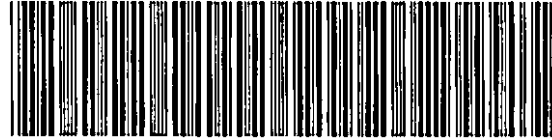

ARTICLES OF MERGER

of

CSI at TGC, LLC,

a Delaware limited liability company

Pursuant to Section 605.1025 of the Florida Revised Limited Liability Company Act (the "Act"), the following Articles of Merger are adopted by **CSI at TGC, LLC**, a Florida limited liability company and **CADDIE SERVICES, LLC**, a Delaware limited liability company.

1. Caddie Services, LLC, a Delaware limited liability company, is the surviving entity ("Surviving Entity"). CSI at TGC, LLC, a Florida limited liability company, is the merging entity. The Florida Document Number of CSI at TGC, LLC is L15000149994.

2. The merger was approved by CSI at TGC, LLC in accordance with Sections 605.1021-605.1026 of the Act; by the Surviving Entity in accordance with the laws of the State of Delaware; and by each member of CSI at TGC, LLC, who as a result of the merger will have interest holder liability under Section 605.1023(1)(b) of the Act.

3. The Surviving Entity has a certificate of authority to transact business in this state and its Florida Document Number is M16000001198.


4. The merger is to become effective at 11:59 p.m. on December 31, 2017.

5. The Surviving Entity agrees to pay any members with appraisal rights the amounts such members are entitled to in accordance with Sections 605.1006 and 605.1061 - 605.1072, Florida Statutes.
