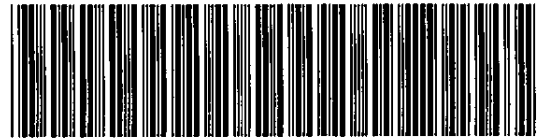

ARTICLES OF MERGER

Pursuant to Section 605.1025 of the Florida Revised Limited Liability Company Act (the "Act"), the following Articles of Merger are adopted by **CM at NFCP, LLC**, a Florida limited liability company and **CADDIE MASTER ENTERPRISES, LLC**, a Delaware limited liability company.

1. Caddie Master Enterprises, LLC, a Delaware limited liability company, is the surviving entity ("Surviving Entity"). CM at NFCP, LLC, a Florida limited liability company, the merging limited liability company, is a Florida limited liability company. The Florida Document Number of CM at NFCP, LLC is L12000104618.

2. The merger was approved by CM at NFCP, LLC in accordance with Sections 605.1021-605.1026 of the Act; by the Surviving Entity in accordance with the laws of the State of Delaware; and by each member of CM at NFCP, LLC, who as a result of the merger will have interest holder liability under Section 605.1023(1)(b) of the Act.
