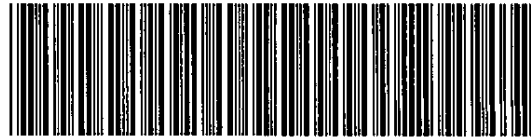

1. Caddie Master Enterprises, LLC, a Delaware limited liability company, is the surviving entity ("Surviving Entity"). 3. The Surviving Entity has a certificate of authority to transact business in this state and its Florida Document Number is M16000001201.


4. The merger is to become effective at 11:59 p.m. on December 31, 2016.
