

This letter is to provide explanation that document number W16000060581 for Prime Score (USA) LLC be reactive as the reason of rejection of filing due to name unavailable isn't applied to this case.

Both companies, Prime Score USA LLC and Prime Score (USA) LLC were all registered by me and I had completed the cancellation process to cancel the first one. Per client's request, I registered the first company named Prime Score USA LLC on August 11, 2016. On August 12, 2016, I discovered the LLC has been registered and doing business in the State of Washington and the registration with Florida Department of State needs to be corrected to be a foreign limited liability company. We sent emails, made phone calls and spoke to sunbiz's representative and was instructed to pay a cancellation fee of \$25 by credit card (receipt attached) to request an immediate cancellation over the phone followed by an on-line withdrawal.

Registration of a foreign limited liability company can only be submitted by mail. Upon receipt of required Certificate of Existence from Secretary of State of Washington, we mailed in a registration package to register Prime Score (USA), LLC, and a foreign LLC to the State of Florida. Since the cancellation of the first LLC was not in effect, I emailed, called and talked to a Sunbiz representative again and received instruction to place a second cancellation. (See attached Detail by Entity.)

Since reason of rejection of filing no longer exists and no need to select an alternate name for use in the state of Florida, please kindly record our registration as the same as shown on the application form.
