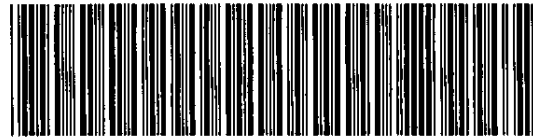



So the bottom line is that we are dissolving the Florida entity and reapplying using the same name as a foreign entity.


All paperwork is attached and I have enclosed a check for the dissolution and for the application for Foreign entity. Please email me or call me to discuss if you have any questions.
