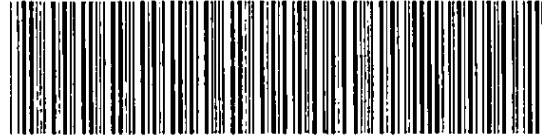


Fourth: The Articles of Merger shall be effective upon filing with the Secretary of State of Florida.


