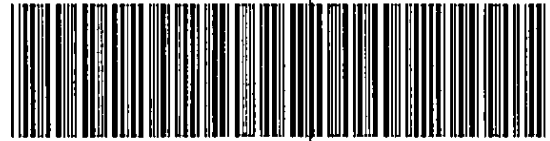

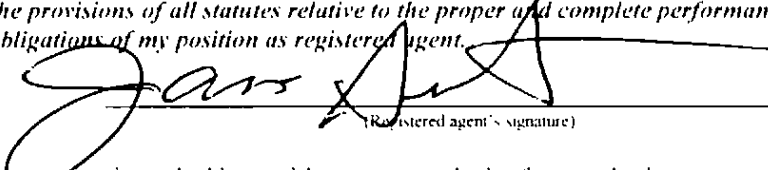

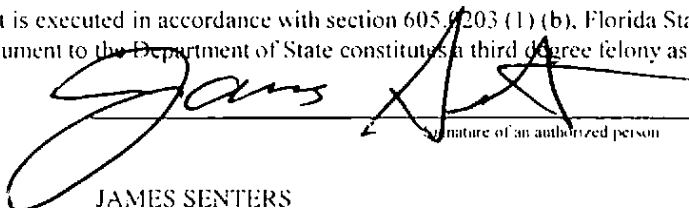

BYLAWS OF

(A California Corporation)

ARTICLE I OFFICE

SECTION 1.1 PRINCIPAL EXECUTIVE OFFICE

The location of the principal executive office of the corporation shall be fixed by the board of directors. It may be located at any place within or without the state of California. The corporation shall have and maintain a registered agent in the State of California and in all other states in which it is required by applicable law.

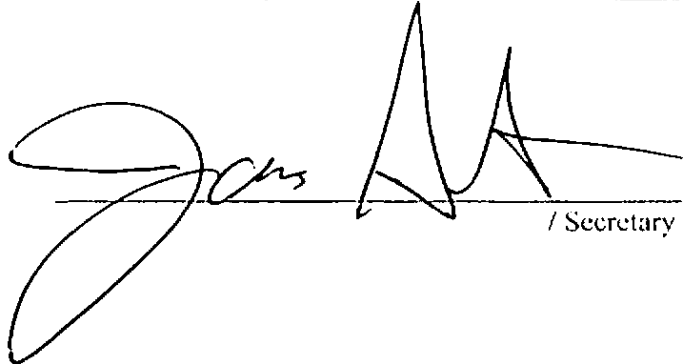
