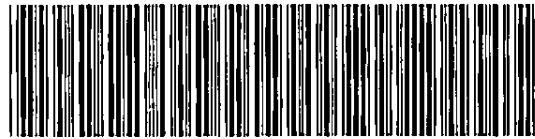

RKWP, LLC was formed as an Illinois limited liability company (LLC) on June 22, 2018. RKWP intended to register as a foreign LLC in Florida. However, due to inadvertent clerical error, RKWP registered as a Florida LLC on October 28, 2018, under Document Number L18000245300. To remedy this error, RKWP was voluntarily dissolved on November 2, 2018. Since then, RKWP filed paperwork under Document Number W18000103190 to register with your office as a foreign LLC.

In order to facilitate this registration, RKWP hereby consents to the release of its name as domestic LLC to itself as a foreign LLC. 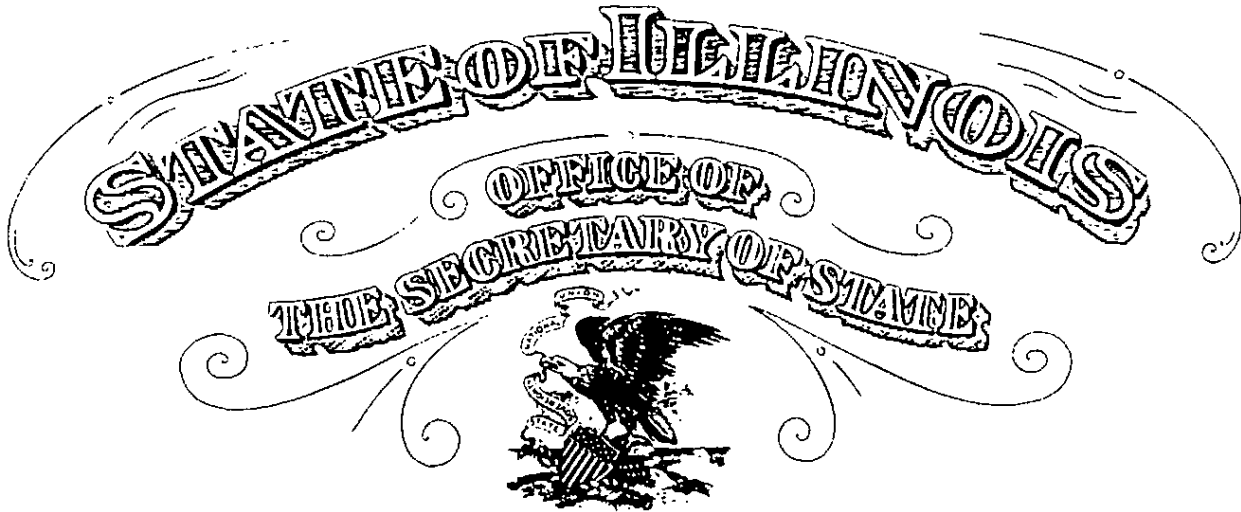
