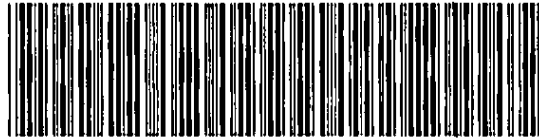

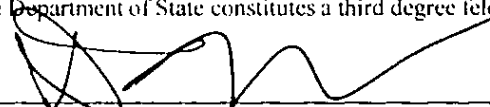

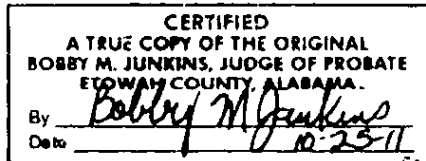

The undersigned, for the purpose of forming a limited liability company under Title 10, Chapter 12, of the Code of Alabama (1975), as amended (the "Alabama Limited Liability Company Act"), hereby file the following Articles of Organization with the Probate Judge of Etowah County, Alabama, and affirm that the facts stated in these Articles of Organization are true and correct:

ARTICLE I

NAME OF COMPANY: The name of the limited liability company is Breeze RV, LLC, (the "Company").

ARTICLE II

DURATION: The period of duration of the Company shall be from the date of filing of these Articles of Organization with the Office of the Probate Judge for Etowah County, Alabama, until the first to occur of the following:

- (1) Fifty (50) years from the date of filing of these Articles of Organization; or
- (2) Dissolution of the Company pursuant to the laws of the State of Alabama or the Operating Agreement of the Company, as in effect from time to time.

ARTICLE III

PURPOSES AND POWERS: The purposes for which the Company is organized are to retail and wholesale recreational vehicles and other related matters within and without the State of Alabama, and any other lawful purpose for limited liability companies organized and existing by virtue of the laws of the State of Alabama. Additionally, the Company shall have all the powers vested in a limited liability company organized and existing by virtue of the laws of the State of Alabama.

ARTICLE IV
