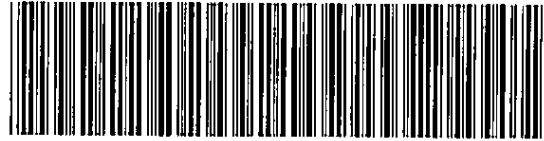

Good Morning Brooke,

I am writing in reference to the rejection of the registration of Jenkins Plumbing Company Foreign LLC due to the name not available. This is due to the fact that when I first registered with the Florida Department of State I incorrectly registered as a Florida LLC when I should have registered as a Foreign LLC. When I called to see what I needed to do to correct this error I then filed the dissolution of the Florida LLC and proceeded to file with the same name as a Foreign LLC as I had been advised by the Florida Department of State. I have no intention of revoking the dissolution of the Jenkins Plumbing Company Florida LLC and would like to proceed with registering as Jenkins Plumbing Company Foreign LLC.
