Dear Sir or Madam:

I am counsel for Flight Services & Systems, LLC, an Ohio Limited Liability Company. As I explained to a representative the Division of Corporations' Registration Section earlier this week, the company recently learned that its Application for Registration of a Foreign Limited Liability Company, filed on October 21, 2019, had been rejected. Apparently, this was due to the similarity of the LLC's name to that of Flight Services & Systems, Inc., an Ohio Corporation, which, also on October 21, 2019, withdrew its authorization to do business in Florida. Flight Services & Systems, Inc. in fact was converted to an LLC, under Ohio law. The company intended to simultaneously withdraw the corporation's authorization and apply for authorization of the converted LLC.

At the instruction of the Division of Corporation's representative, I am enclosing a letter from Robert A. Weitzel, CEO of Flight Services & Systems, LLC, granting the LLC permission of the use of the name of the company for the purpose of the Application for Registration of a Foreign Limited Liability Company. 
