

I am counsel for Flight Services & Systems, LLC, an Ohio Limited Liability Company. As I explained to a representative the Division of Corporations' Registration Section earlier this week, the company recently learned that its Application for Registration of a Foreign Limited Liability Company, filed on October 21, 2019, had been rejected. Apparently, this was due to the similarity of the LLC's name to that Flight Services & Systems, Inc., an Ohio Corporation, which, also on October 21, 2019, withdrew its authorization to do business in Florida. Flight Services & Systems, Inc. in fact was converted to an LLC, under Ohio law. The company intended to simultaneously withdraw the corporation's authorization and apply for authorization of the converted LLC.
