



RESOLUTION TO REMOVE FROM POWDERED SUGAR PROPERTIES LLC

On this day, 16 November 2022, Bret Morrison, an individual, withdraws from membership in POWDERED SUGAR PROPERTIES, LLC, a Delaware Limited Liability Company (the "Company"), in exchange for payment from Darin Wilson, an individual, of \$245,843.36. Payment is to be issued as follows:
