

I'm writing in response to your letter dated April 24, 2021, in which you rejected the application for registration of the foreign LLC, Macondo Trading LLC, on the grounds that a \$500 civil penalty must be paid along with an annual report filing fee for 2020, based on the application, stating that the LLC had transacted business in Florida as of December 2020.

Upon receiving your letter, we looked carefully into the definition of transacting business in the state, and in fact we believe that Macondo Trading LLC, which is a startup company with no employees still developing its product line and strategy, has in fact not yet transacted business in Florida. We are therefore requesting that our application for authorization to transact business in Florida be granted without penalty or retroactive annual report filing fee.

The transaction in December 2020 that we had in mind when filling out the application was the out-of-state sale of some early samples from our upcoming product line. None of these samples were sold to customers within Florida. Furthermore, since December, no other sales have occurred, whether in-state or out of state. In its purchasing and expense history to-date, Macondo Trading LLC has incurred only some minor incidental expenses related to its business startup, all paid to foreign or out-of-state vendors.

I trust that with this clarification, you will accept the application of Macondo Trading LLC for registration to do business in Florida without penalty or further requirement, on the basis of the corrected application we are hereby submitting and the \$130 fee already paid to the Florida Department of State (see copy of cashed check as evidence of receipt of funds by FL DOS).
