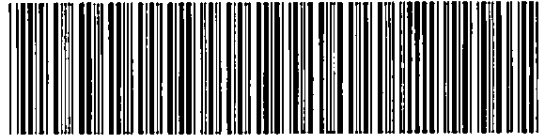

FIRST: The name of the Company prior to any changes effected by this Certificate of Amendment is Concert Amelia OpCo, LLC.

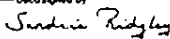
SECOND: The Certificate of Formation of the Company is hereby amended as follows:
