1. This Statement of Fact is being provided to confirm that RICKIE E. STROWBRIDGE has never been authorized to act in any capacity for MCENANY ROOFING, INC. and that fraudulent Amended Annual Reports were posted with the Department of State on October 5, 2022 and October 6, 2022, as further described below:
2. On October 5, 2022, an Amended Annual Report was filed with the Florida Department of State under filing number 9160632547CC without my knowledge or consent changing the following information on file with the Department of State without my consent or knowledge:
 - a. The mailing address of MCENANY ROOFING, INC. was changed to 3140 Bay Shore Road, Sarasota, FL 34234;
 - b. All current Officers and Directors of MCENANY ROOFING, INC. were deleted and replaced with RICKIE E. STROWBRIDGE with the title President; and
 - c. The acting Registered Agent was removed and replaced with RICKIE E. STROWBRIDGE; and
 - d. Such Amended Annual Report was electronically signed by "RICKIE E. STROWBRIDGE, President"; and
 - e. None of the above changes were authorized or considered by MCENANY ROOFING, INC. to be effective; and
3. **RICKIE E. STROWBRIDGE is not known to me; and**
4. On October 6, 2022, when I became aware of the above fraudulent activity of October 5, 2022, I authorized my attorney, ALAN S. GASSMAN, ESQ., to file an Amended Annual Report (filing number 0819877505CC) to remove RICKIE E.


STROWBRIDGE and update the mailing address, Registered Agent and Officer/Director detail to provide corrected information for MCENANY ROOFING, INC. to the Department of State, and

5. On October 6, 2022, a second Amended Annual Report was filed with the Department of State (filing number 5686905070CC) changing the EIN of MCENANY ROOFING, INC. to an incorrect EIN (88-4143922) without my knowledge or consent and such Amended Annual Report was electronically signed by "RICKIE E. STROWBRIDGE, President"; and
6. On October 7, 2022, when I became aware of the above fraudulent activity of October 6, 2022, I authorized my attorney, ALAN S. GASSMAN, ESQ., to file an Amended Annual Report (filing number 6272187275CC) to correct the EIN of MCENANY ROOFING, INC. to EIN 59-2583665 in Department of State records.
