Gentlemen:

We have received your form, Application for Reinstatement related to the captioned taxpayer. Although, I understand that the reinstatement fee for late filing of the Annual Report has been created by statute and cannot be waived by your office, we would ask that your office consider the following extenuating circumstances. We have enclosed a copy of the taxpayer's check register detailing consecutive check numbers 0026043, 0026044 and 0026045. Check number 0026043 and 0026045 cleared the bank shortly after the dates written and check number 0026044 payable to the Department of State remained outstanding for a period of time. Subsequently, this office voided the check assuming that the check would not clear the bank or that the check was lost. This office's bookkeeper was completely unaware of the nature of the check or the form that could have been attached to this check when it was originally mailed. We can obtain confirmation from the taxpayers' bank, Barnett Bank, that the taxpayer maintained, at all times, balances in the high six figures, and more times than not, in the low seven figures. There was never a time that the taxpayer could not afford payment of this \$165.00 and further is obvious that the taxpayer's check number 0026044 dated March 19, 1997 was well in compliance with your April 30, 1997 deadline.

We would therefore request that you accept the enclosed reinstatement together with the taxpayer's check for \$165.00 and abate the reinstatement penalties associated herewith in that the taxpayer timely prepared and filed their 1997 Annual Report. Due to extenuating circumstances beyond their control, it appears that the form was never received by your office and clearly that the check never cleared the bank.
