**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
RAMON J. IGLESIAS, M.D. PROFESSIONAL ASSOCIATION**

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, RAMON J. IGLESIAS, M.D. PROFESSIONAL ASSOCIATION, a Florida corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. ARTICLE I of the Articles of Incorporation of the Corporation shall be amended to read as follows:

"ARTICLE I.

"The name of this Corporation is RAMON J. IGLESIAS, M.D., INC."


2. For purposes of these Articles of Amendment, the Effective Date shall be the date of filing of these Articles of Amendment with the Secretary of State of the State of Florida.
