





Our firm represents Quality Cabling Solutions LLC, a Missouri limited liability company (the "Missouri LLC").

Previously, Articles of Organization for Quality Cabling Solutions LLC (the "Florida LLC") were filed with your office on June 6, 2023. 

6. On June 20, 2023, the Florida LLC voluntarily dissolved, as reflected on the Certificate issued by the Florida Secretary of State June 22, 2023, attached hereto as Exhibit A.

The Florida LLC, having been formally dissolved, will not be reactivated as a Florida domestic limited liability company, and has released the name "Quality Cabling Solutions LLC" to permit Quality Cabling Solutions LLC, a Missouri limited liability company, to submit a new application for foreign registration under the name "Quality Cabling Solutions LLC".





