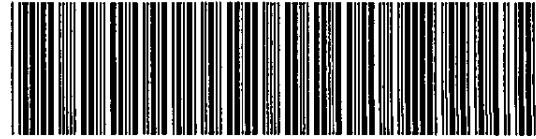




1. The name of the corporation is CREATIVE STAFFING, INC.
