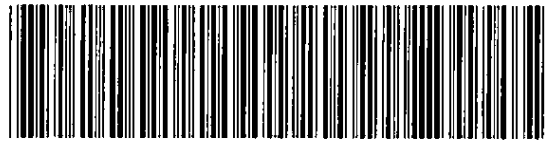

We have submitted for filing with your office (1) an Application by Foreign Corporation for Withdrawal of Authority to Transact Business or Conduct Affairs in Florida for **SRTI Blockchain Generation Incorporated, a Delaware limited liability company** and (2) an Application by Foreign Limited Liability Company for Authorization to Transact Business in Florida for **SRTI Blockchain Generation LLC, a Delaware corporation**.

By way of background, SRTI Blockchain Generation Incorporated was acquired by Alimco Financial Corporation pursuant to an Agreement and Plan of Merger among Alimco Financial Corporation, Alimco Financial Merger Sub Corporation, SRTI Blockchain Generation Incorporated and Lee M. Gopadze dated February 23, 2023 (the “Merger Agreement”). Under the terms of the Merger Agreement, SRTI Blockchain Generation Incorporated was converted from a Delaware corporation to a Delaware limited liability company named SRTI Blockchain Generation LLC. Pursuant to the terms of the Merger Agreement, Alimco Re Ltd, a wholly-owned subsidiary of Alimco Financial Corporation, became the sole member of SRTI Blockchain Generation LLC.


