My client, John Kramer, forwarded your May 29, 2024, letter to me for response (see enclosed copy) regarding the above referenced matter. As you know, Mr. Kramer applied to have his New York LLC, ORACLE LLC, registered to do business in the State of Florida (see enclosed copy of his Application), which was denied by you stating the name was taken and not available. A review of the ORACLE LLC's on your site indicate all are not active. ORACLE LLC, Document Number L130000004618 was voluntarily dissolved on July 02, 2014; ORACLE LLC, Document Number L17000139824 was administratively dissolved on June 27, 2017, and ORACLE LLC, Document Number L20000106995 was administratively dissolved on September 24, 2021 (see enclosed copies). A research of your website indicates that if an LLC is dissolved and not reinstated within one year, the name may be used by someone else. Therefore, my client is requesting the use of ORACLE LLC due to the fact his business and banking records all have that name. If you deny his request, then he wants to use 1ORACLE LLC.


Your letter indicates Mr. Kramer owes a penalty of \$777.50 for conducting business in the State of Florida without registration. The only thing ORACLE LLC did in Florida was one real estate transaction (see enclosed copy of email and HUD statement). Pursuant to Fla. Stat. Sec. 605.0905 (see enclosed copy), that activity is exempt and does not constitute transacting business.
