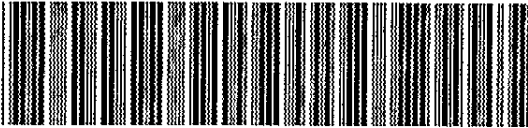

ARTICLES OF INCORPORATION
OF

BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

- 1. NAME. The name of this corporation is:
GABRIEL SANCHEZ, M.D., P.A.
- 2. TERM. This corporation shall exist perpetually.
- 3. PURPOSE. The purpose of this corporation is to engage in the practice of the professional service of medicine, including the transaction of all lawful business for which corporations may be incorporated under Florida laws, and to exercise the powers now or hereafter granted to professional service corporations.

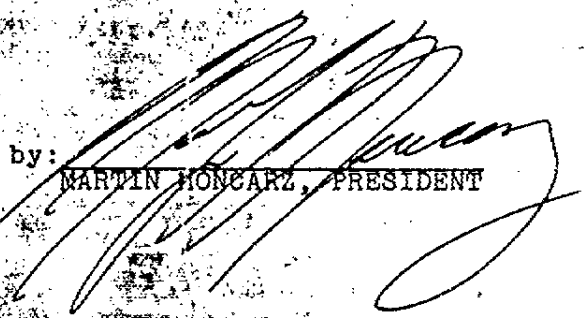
